The Communications Regulatory Authority of Namibia, in terms of section 53(10) of the Communications Act, 2009 (Act No. 8 of 2009) read with regulation 8(1) of the "Regulations regarding the Submission of Interconnection Agreements and Tariffs", published in Government Gazette No. 4714, General Notice No. 126, dated 18 May 2011, herewith gives notice that Telepassport Communications (Pty) Ltd has filed a tariff with the Authority as set out in Schedule 1.

NOTICE IN TERMS OF REGULATION 19(1) OF THE REGULATIONS REGARDING LICENSING PROCEDURES FOR TELECOMMUNICATIONS AND BROADCASTING SERVICE LICENCES: COMMUNICATIONS ACT, 2009

The Communications Regulatory Authority of Namibia, in terms of regulation 19(1) of the Regulations regarding Licensing Procedures for Telecommunications and Broadcasting Service Licences, published in Government Gazette No. 4785, General Notice No. 272, on 29 August 2011 (as amended), hereby gives notice of the following decisions:

1. Broadcasting Service Licence

The Authority resolved to approve the renewal of the Community Broadcasting Service Licence for **GOSPEL MISSION MINISTRIES t/a KAIROS RADIO STATION.**

2. Spectrum Licences

(a) The Authority resolved to award a Spectrum Licence for the provision of broadcasting services to **SATELIO TELEVISION NAMIBIA (PTY) LTD** as set out hereunder –

(b) The Authority resolved to cancel the Spectrum Licence awarded to **TELECOM NAMIBIA LIMITED** as set out hereunder –

- (i) The cancellation is effective from the date of publication of the final notice in the *Gazette*; whereby the Licensee is allowed
 - (a) 6 months from the date of the notice referred to in (i) to migrate urban areas within the Khomas, Erongo, Kavango West, and Oshana regions;
 - (b) 9 months from the date of the notice referred to in (i) to migrate urban areas in all other regions than those set out in (a); and
 - (c) 24 months from the date of the notice referred to in (i) to migrate all rural areas within the borders of Namibia.
- (ii) In addition, the Authority resolved that Telecom Namibia must provide quarterly reports on the progress made in the migration process and subsequent discontinuation of the WiMAX services.

3. Reconsideration Applications

- (a) The Authority considered the reconsideration application filed by **TELECOM NAMIBIA LIMITED** on the Authority's decision to cancel the spectrum licences awarded to Telecom Namibia Limited in the 2348 2386 MHz spectrum band and resolved as set out hereunder –
- (i) To decline Telecom Namibia Limited's reconsideration application as the Authority is of the opinion that Telecom did not raise any substantial grounds to justify reconsideration of the Authority's decision.
- (ii) That the Authority's decision of 23 April 2024 shall remain in force.
- (b) The Authority considered the reconsideration application filed by **UCOM MOBILE NAMIBIA (PTY) LTD** on the Authority's decision to cancel the spectrum licences awarded to **UCOM MOBILE NAMIBIA** in the 791-801 MHz paired with 832-842 spectrum band and resolved as set out hereunder –
- (i) To decline the reconsideration application and uphold the Authority's decision dated 16 February 2024 and 8 December 2023 in accordance with section 31 of the Communications Act, 2009 and regulation 36 of the Regulations prescribing the Procedure regarding Application for, Amendment, Renewal, Transfer and Cancellation of Spectrum Licences.
- (ii) The Authority further reiterates its decision of 16 February 2023 wherein it declined the reconsideration of the cancellation of UCOM's spectrum licence in the 791-801 MHz paired with 832-842 spectrum band. Thus, these decisions shall remain in force.
- (iii) That UCOM ceases utilisation of the aforementioned spectrum licence with immediate effect.

(iv) The above decisions shall be effective upon receipt of the decision letter to UCOM.

Save for those decisions of the Authority with specific effective dates as stipulated above, all the other decisions are effective from the date of publication of this Notice.

The full reasons for the decisions can be requested from the Authority. In terms of section 31 of the Communications Act, 2009 (Act No. 8 of 2009), the Authority may, on its own motion or on a petition filed by an aggrieved party to any proceedings, reconsider any order or decision that it has made, within 90 days of this notice.
